

**CHAUVE HAIR REMOVAL & SPA GIVEAWAYS  
OFFICIAL CONTEST RULES**

1. **GENERAL:** By submitting an entry to this contest, sponsored by Chauve Hair Removal & Spa (“Contest Sponsor”), the entrant acknowledges and agrees to all of these Official Rules. By entering the drawing, entrant agrees to waive any right to claim any ambiguity or error in these Official Rules, or the drawing itself, and agrees to be bound by these Official Rules and by all decisions of the Contest Sponsor, whose decisions are binding and final. The Contest Sponsor reserves the right to withdraw the transmission of this sweepstakes and award the prize from among entries received prior to the date of the withdrawal. Failure to comply with these rules may result in disqualification from this contest. **NO PURCHASE NECESSARY.** Void where prohibited. Contest begins on September 18, 2007 at 12:00 am and ends on September 30, 2008 at 11:59 pm. All times in this contest refer to Mountain Time.
2. **ELIGIBILITY REQUIREMENTS:** The contest is open only to legal U.S. residents (residing in the states of Utah, Colorado, Idaho, Nevada and Wyoming) who are 18 years of age or older as of September 1, 2007. Void where prohibited or restricted by applicable federal or state laws and regulations.
3. **HOW TO ENTER:** You may enter the contest by completing the online entry form, which includes your name, address, phone number and email address. You may enter once during the contest period. Multiple entries received from any person or email addresses will void all entries. Entries generated by any automated form of entry will be disqualified. Entries that are incomplete are void and will not be accepted. All entries become the property of the Contest Sponsor and will not be acknowledged or returned. All online entries must be received before 11:59 pm Mountain Time on September 30, 2008 to be eligible for the drawing.
4. **SELECTION OF WINNER:** One First Prize winner will be selected through a random drawing by employees of the Contest Sponsor. Upon receiving 100 entries, the Contest Sponsor will make an initial drawing. Another contest will begin immediately with prizes distributed as described above (1 First Prize).
